The Dahlonega Farmers Market is hosted by the City of Dahlonega, and it is governed by City of Dahlonega ordinances and regulations. The City Code Enforcement Officer will ensure permit holders comply with ordinances and regulations. Any violations may result in immediate and permanent revocation of the vendor's permit.

RULES AND REGULATIONS

- 1. The 2014 Farmers Market will be open for our farmers and customers every Saturday & Tuesday, May 3 through October 11. <u>Saturday hours are 8 AM noon. Tuesday hours are 3 PM 6 PM.</u>
- 2. Only agricultural items grown or produced in Lumpkin County or adjacent counties (Hall, Dawson, White, Fannin, Gilmer, and Union) can be sold.
- All packaged foods (canned goods, baked goods, etc.) must contain products that the maker/seller has grown. All packaged foods must be labeled with the maker/seller's name and contact information (address and/or phone number). ALL ingredients must be listed on the label. This is specified by The Georgia Department of Agriculture and is aimed to protect buyers with allergies.
- 4. Individuals desiring to produce and offer for sale eggs shall have an Egg Candling certificate from The Georgia Department of Agriculture. The eggs must be stored in an ice chest with cool packs and be properly labeled.
- 5. Individuals desiring to produce and offer for sale meat products must have processed the product in a USDA licensed facility. The product must bear the USDA legend and be properly labeled. The vendor must also have a Mobile Meat license, mechanical refrigerated holding unit and a certified scale at the point of sale.
- 6. Individuals desiring to produce and offer for sale dairy products must have a Food Sales Establishment License coded as a (430 Grade A Milk Plant) through the Georgia Department of Agriculture.
- 7. Certain foods specified by the Georgia Department of Agriculture require licensing from the Department of Agriculture and compliance with their "Food Processing Safety" Guidelines. The Dahlonega Farmers Market requires vendors who wish to sell such items to be licensed by the Georgia Department of Agriculture and requires that license to be posted at the sales booth at all times.
- 8. Farmers may bring their own table and/or tent. Each farmer will be allotted 10 feet x 10 feet of space for each permit issued. An additional permit is required if your space needs exceed 10 feet x 10 feet but a vendor will not be issued a permit for more than 2 contiguous 10 feet x 10 feet spaces (additional inventory may be stored in your vehicle for restocking). Farmers are only allowed to set up in the mulched areas of Hancock Park along the sidewalks of Warwick St, Park St, Hawkins St and Meaders St.
- 9. Farmers will be allowed to sell from a truck no larger than 3/4 ton size by special arrangements only.
- 10. Farmers must display a copy of their current permit (and state license if applicable) at their sales table/area. (For your privacy, you may mark through your phone number and email address if you choose.)
- 11. Farmers must agree to leave the market space clean.
- 12. The use of tobacco products by vendors in Hancock Park is prohibited.
